

Privacy Notice and Consent to Use and Disclose Contact Informatiom

The purpose of this Privacy Notice is to provide information concerning the collection and use of your personal data and explains the rights and choices available to you with respect to your information.

What personal data is collected if you opt-in to receive communications?

In connection with your opt-in, the personal data that you provide, including your name, contact details, reason you disclose as to why you are interested in PKU, and any information you input into our form.

How is your personal data used?

We may use personal information for the following purposes:

- Notifying you about company news and its research and science
- Responding to requests, inquiries, comments, and suggestions
- Staffing, facilitating, conducting and managing clinical trials
- Defining and managing appropriate patient engagement activities

To whom could the personal data be disclosed?

In connection with the above purposes, Synlogic may disclose the personal data to the following categories of recipients:

- a) Employees and contractors with a need to know to fulfill the purposes of the use of personal data
- b) Service providers that perform services on our behalf, including contract research organizations
- c) Our technology providers (including technology support, and email and web hosting providers)

In the rare cases, the personal data may be used in connection with investigations or legal proceedings, in which case the personal data may be disclosed to law enforcement agencies or other governmental authorities.

In connection with any of the above purposes, the personal data may be transmitted to countries outside the European Union which are not regarded as providing an adequate level of protection for personal data, such as the United States. In those cases, your personal data shall only be transferred where appropriate safeguards are in place to protect your personal data.

Synlogic has agreements in place with its employees and the service providers who may have access to the personal data as described above, under which they are bound to keep your information confidential and not to use it for any other reason other than for the purposes described in this notice.

Legal Basis for Processing:

The legal basis for the collection and use of the personal data is:

- Your consent below
- Legitimate Interests: Where it is necessary for our legitimate interests (or those of a third party) and your interests and fundamental rights do not override those interests

Personal Data Retention:

We will only retain your personal information for as long as necessary to fulfill the purposes we collected it for. To determine the appropriate retention period for personal data, we consider the amount, nature, and sensitivity of the personal data, the potential risk of harm from unauthorized use or disclosure of your personal data, the purposes for which we process your personal data and whether we can achieve those purposes through other means, and the applicable legal requirements.

Data Security:

Synlogic has put measures put in place to prevent your personal information from being accidentally lost, used or accessed in an unauthorized way, altered or disclosed. Synlogic has put in place procedures to deal with any suspected data security breach and will notify you and any applicable regulator of a suspected breach where we are legally required to do so.

What are the rights to personal data?

You are entitled at any time to access their personal data and/or, to the extent legally permissible, to have such information deleted or corrected or to object to the processing of the personal data, to request the restriction of the processing of the personal data, or to revoke your consent.
